This report is due for each and every address in your Grower Registration Agreement and must include each field address identified in your Registration Agreement. If you will NOT plant at a Location ID in your Grower Registration, **report of a “No Planting” is required**, by completing the Location ID field(s) in Question 2 and check the “No Planting” box in the far right column. If no planting has occurred before July 31st of a registered year, a registered grower shall withdraw their grower’s registration **or** fill out your intended planting dates in Question 7. Use separate forms for different addresses.

Directions: Complete all parts of the following report and submit the report and all required attachments to Alaska Plant Materials Center Hemp Program, 5310 S. Bodenburg Spur, Palmer, AK 99645. The report must be complete, accurate and legible. Follow all instructions in the document. Be sure to keep a copy of the full report for your records.
