This report is due for each and every address in your Grower Registration Agreement and must include every field or indoor planted area identified in your Registration Agreement. Use separate forms for different addresses.

Directions: Complete all parts of the following form and submit the report and all required attachments to Alaska Plant Materials Center Hemp Program, 5310 S. Bodenburg Spur, Palmer, AK 99645. The report must be complete, accurate and legible. Follow all instructions in the document. Be sure to keep a copy of the full report for your records.
